Superintendent's Consent Items

- Approve hiring up to 5 adults for summer maintenance help at the custodian substitute pay rate for up to 32 hours per week.
- Approve hiring up to 2 students for summer maintenance help at a rate of \$9.30 per hour up to 20 hours per week.
- Approve hiring up to 2 students for summer maintenance help at a rate of \$9.30 per hour. Total hours will not exceed 40 hours per week per student.
- Approve hiring one student for summer technology help at a rate of \$9.35 per hour. Total hours will not exceed 240 hours.
- Approve hiring 1 adult for summer technology help at the custodian substitute pay rate for up to 120 hours.
